You will need:

To verify you are on Rate 211 - find the section near the middle of your AES Ohio bill labeled "Usage Detail", below which the column titled "Rate" should read 211.

Your monthly kWh Usage is to the left of your Rate number on your AES Ohio bill. See example below.
