RENTAL CHARGE SCHEDULE

- 1. AVAILABILITY. (a) Except as provided below, this tariff is applicable to any "Attaching Entity" as defined in Section 4901:1-3-01(A) of the Ohio Administrative Code (OAC) (hereinafter called "Attachor") who attaches any facilities to poles and in rights-of-way owned by The Dayton Power and Light Company (hereinafter called "Owner" or "Company") or installs any facilities on, in, or along, ducts and conduits and in rights-of-way owned by Company, Attachors and other entities with attachments subject to this Tariff shall be required to execute the "POLES, DUCTS AND CONDUITS ATTACHMENT" agreement ("Tariff Agreement"), substantially in the form set forth in an Exhibit to the General Terms and Conditions set forth in this Tariff. Pursuant to OAC §4901:1-3-01 "Pole attachment" means any attachment by an attaching entity to a pole, duct, conduit, or right-of-way owned or controlled by a public utility.
- (b) This Tariff shall not apply with respect to an entity who has an effective written contract allowing the installation of facilities on Owner's poles, ducts, and conduits on or after the time of the effective date of this Tariff either pursuant to a Joint Use Agreement, Joint Pole Agreement or other agreement irrespective of how captioned that provides for such installation under terms and conditions that are not intended by the parties thereto to be subject to the tariff ("Non-Tariff Agreement").
- **2. LICENSE FEE.** Attachor shall pay to Owner a one-time fee of \$100 for processing of the Tariff Agreement.
- **3.** <u>ATTACHMENT CHARGES</u>. The annual rental fee for attachments to poles shall be based upon the applicable formula for cable attachments as provided for in Section 4901:1-3-04 of the Ohio Administrative Code and as may be modified or amended by the PUCO. As of the effective date of this tariff sheet, the Annual Rental Fee per attachment to poles shall be:

\$8.05 (per foot; minimum one foot)

Unless otherwise indicated, the annual rental fee will be billed and be due and payable no later than the second calendar quarter of the following year.

- (b) These other charges may be updated by Owner periodically to reflect Owner's current costs.
- (c) To the extent applicable and as set forth in the General Terms and Conditions made a part hereof, Attachor shall also be obligated to pay any additional charges, including charges associated with unauthorized and non-compliant attachments as well as for delays in completion of any make ready required for other Attaching Entities.
- **5. GENERAL TERMS AND CONDITIONS.** All of the General Terms and Conditions of this Tariff are applicable to this Rental Charge Schedule and are hereby made a part hereof.
- **6. <u>PUCO JURISDICTION.</u>** This Rental Charge Schedule and the General Terms and Conditions are subject to Section 4901:1-3 of the Ohio Administrative Code and the jurisdiction of the Public Utilities Commission of Ohio.
